ROSEVILLE is a well built, hustling town of 2,500 inhabitants, situated on the main line of the C. & M. V. R. R. and the South Eastern Ohio Interurban Railway.

It lies in a beautiful, picturesque valley surrounded by massive, towering hills, rich with mineral wealth. It is to the vast deposits of potters clay and coal lying in these hills that Roseville owes her supremacy among the pottery and brick manufacturing cities of the nation.

The busy hum of machinery is heard from morn till night in her factories, which are never idle. The demand for the products

turned out of her potteries by skilled workmen is never ceasing, consequently her prosperity and progress is assured for all time to come.

Few small cities of her size have better paved streets or more substantial and beautiful residences. The main thoroughfare and the principal resident streets are paved throughout their length. The town is a model of cleanliness and excellence in its general characteristics.

It enjoys an excellent municipal government and the officials, with characteristic energy, have improved the general appearance of the city in every possible manner. To the present officials is due the credit for many improvements of which the people of Roseville may well be proud.

Her schools are second to none in Muskingum and Perry Counties, both of which the village forms a part.

Her business and industrial establishments are in a most prosperous condition, as the large volume of business transacted daily will attest.

Prominent among the industrial establishments employing hundreds of men are the Ransbottom Bros. Pottery Co., Ohio Press Brick Co., Lowry Bros. Pottery Co., Baldoser and Pace Pottery Co., F. S. Lowry Pottery, J. W. McCoy Pottery Co., and Roseville Pottery Co. These institutions had their initial beginning in Roseville, and their products are of such excellence in quality and workmanship as to be in a demand constantly in excess of the production and capacity of the factories. Superior shipping facilities enable them to send their

products abroad over the land and even to foreign markets. An army of salesmen are employed in introducing the manufactured products to the consumers direct.

The business men mentioned in our History of Roseville are Roseville's Hustlers, who have an interest in the welfare of their town and are deserving of your patronage, not only because their stores are the best the town affords, but because of their ambition to merit your esteem and their fairness to all patrons in Roseville and vicinity. Roseville has several beautiful church edifices and the handsomest school building in the county.

Her artisans and builders are among the most skillful to be found, and evidences of their ability are to be seen on every hand in the handsome residences and substantial buildings which line the streets.

In 1844 Roseville was but a small village. The village was platted in 1812 by John Rose, and was known as New Milford until 1830, when the postoffice was established, with John Allen in charge.

For many years following the mail was carried to and fro on horseback at weekly periods.

The first cabin here was that of Mr. Rose, built in 1814. Robert Allen was the first merchant. John Laughlin kept the first tavern in a log cabin. The first shoemaker was a man named Forgrave.

Elisha Kennedy taught the first school in a log house with a puncheon floor and fitted up in primitive style. The contrast between

the first school house and the present magnificent building can be imagined as striking to the extreme.

Roseville was incorporated in 1840 with a population of 300 souls, having as Mayor, Mr. James Little.

The first bricks produced in Roseville were made by Thomas Moody.

It can safely be asserted that Roseville is the home of the cooking ware manufacturing industry, and Mr. Lyman Lowry, father of the Lowry Bros., is said to be the "Father of the Cooking Ware" industry.

The village is located ten miles southwest of Zanesville on the Perry County line, and lies partially in Perry and Muskingum Counties. The town is famous throughout the United States for its clay products, which are as diversified as

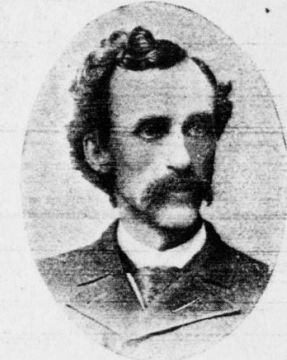

They stand ready and willing to do anything in their power to elevate the schools to the first rank, and place them in such an advanced position that they will be second to none in Muskingum County.

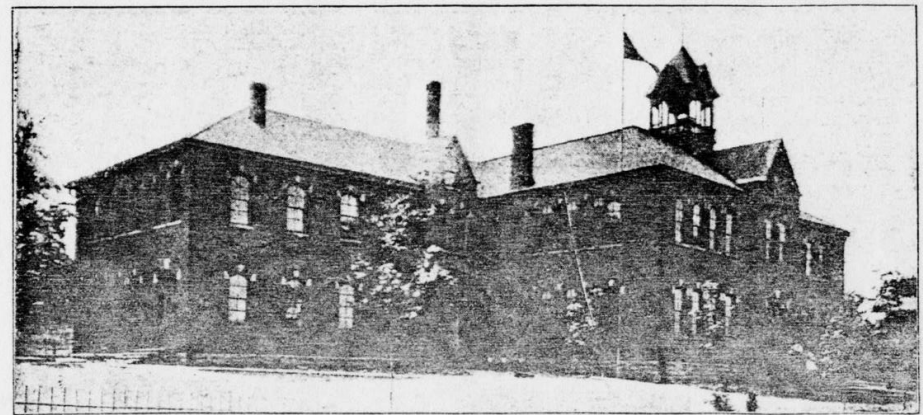
The Superintendent, Carl G. Pemberton, is a home product, having been reared in the village and received his education in the public schools, graduating from the High School in 1892, and continuing his studies since that time at Lima College.

Prof. Pemberton taught eight years in the country schools, and then served as capacity of High School Principal for six years previous to his becoming Superintendent. He has the unique distinction of being the first graduate of the village to be advanced to the high position he now occupies in his native town.

He enjoys the respect and confidence of the pupils and people, and displays

an interest and progressiveness in his noble calling which has resulted in the betterment and advancement of educational conditions in the village.

The High School curriculum embraces four years' work, including two different courses of study, the Latin and English courses, each of which call for four years individual work on the part of the student. The present High School is composed of forty of the brightest boys and girls of the village.

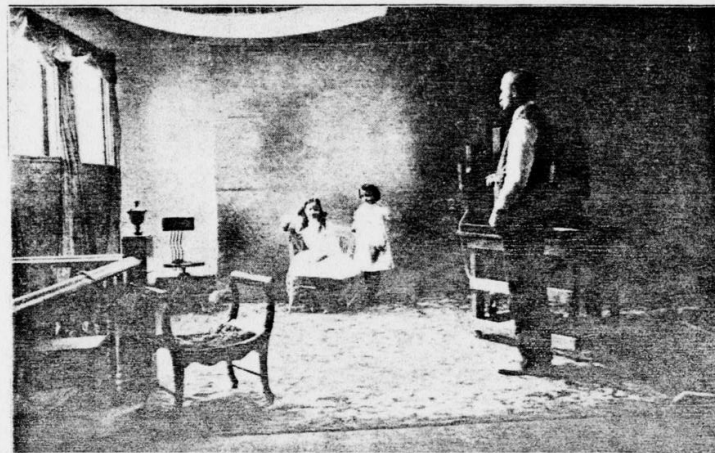
During his railway service he followed his present vocation as a pastime, and soon achieved a reputation as an expert photographer.

Besides handling a line of hardware a line of gas ranges, Buffalo mixed paints, and the famous

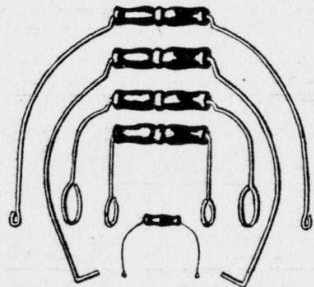
Moore's Air Tight Heaters are sold extensively.

Mr. Zehring keeps several men employed in performing a large amount of roofing and spouting throughout Roseville and vicinity.

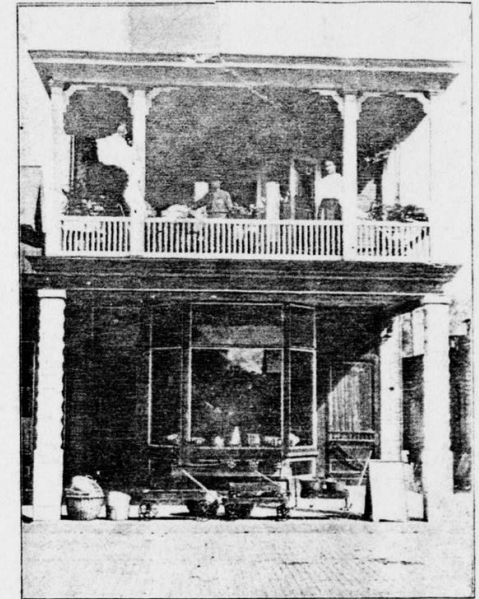

He is a member of the Presbyterian Church and is affiliated with the Masonic, I. O. O. F., K. of P., and M. W. of A. fraternal organizations.

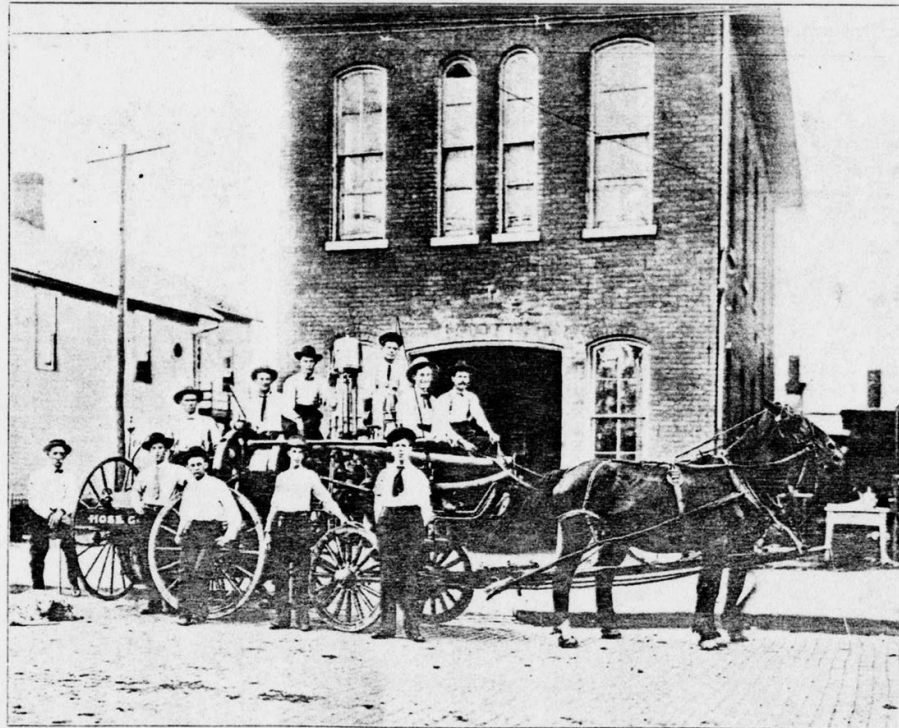


### ROSEVILLE FIRE DEPARTMENT.

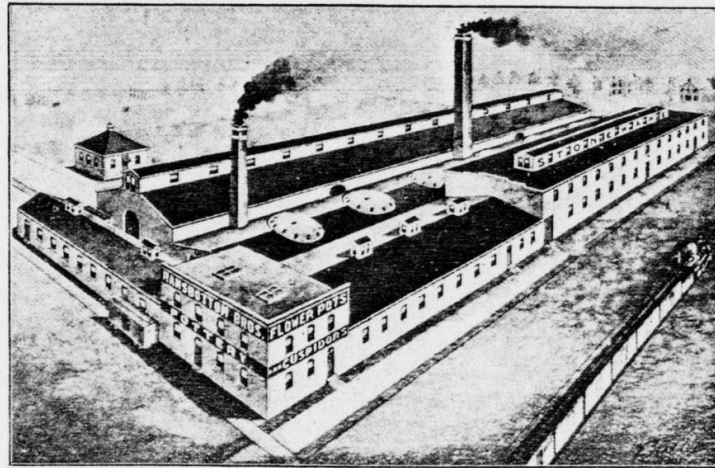

Over one hundred men are constantly employed, entailing a monthly pay roll of over \$6,000,—a considerable item which directly concerns the welfare of Roseville people.

The output of the Roseville establishment is in excess of two cars daily—containing ware with a capacity of 6,000 gallons in each car.

The plant in operation resembles a vast hive of industry, and is a model of neatness and arrangement. A spirit of good will and activity pervades the

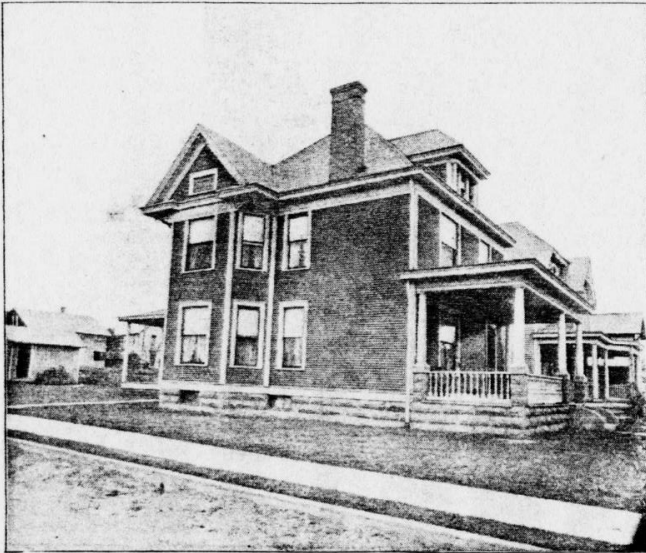

## OHIO PRESS BRICK COMPANY.

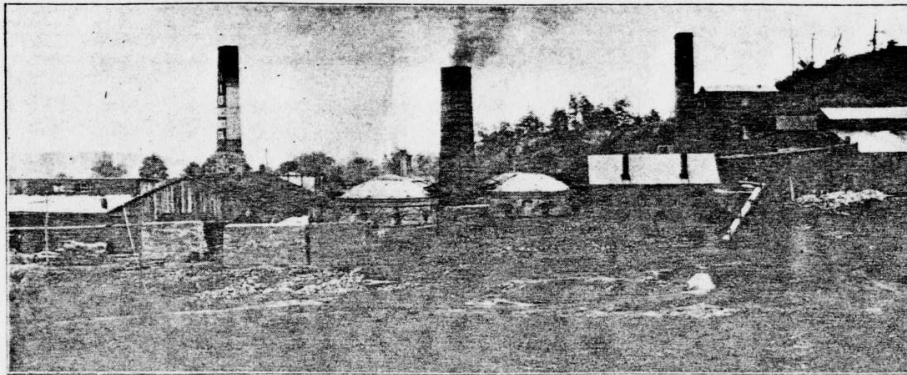

PLANT OF OHIO PRESS BRICK CO.



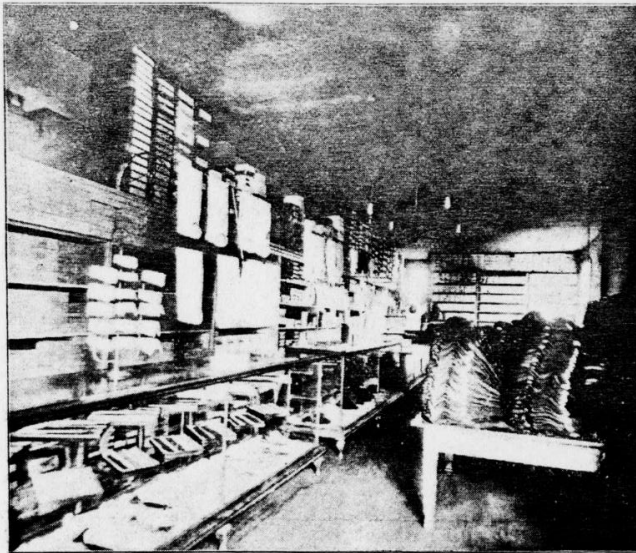

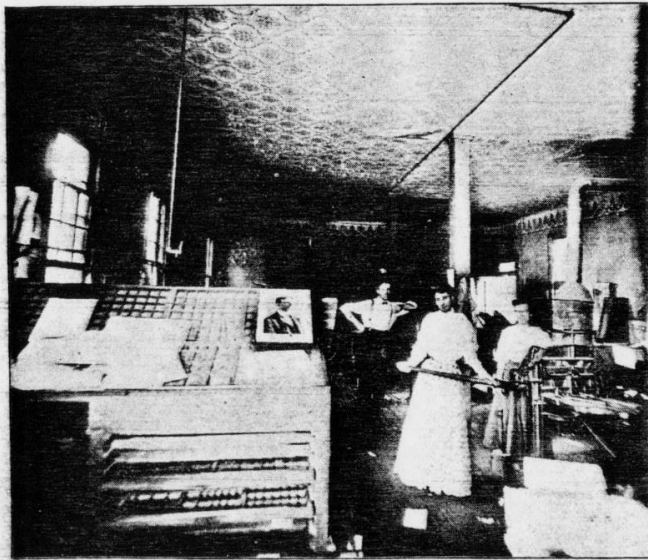
INTERIOR VIEW OF DAVIS AND DILLY'S STORE

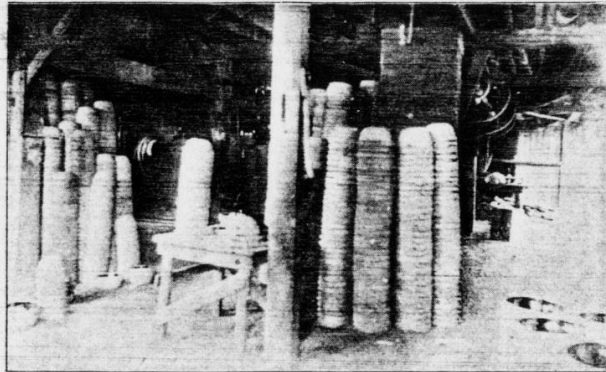

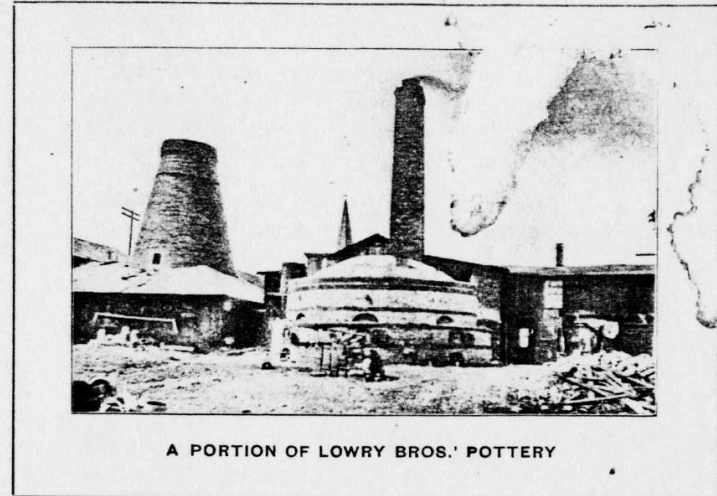

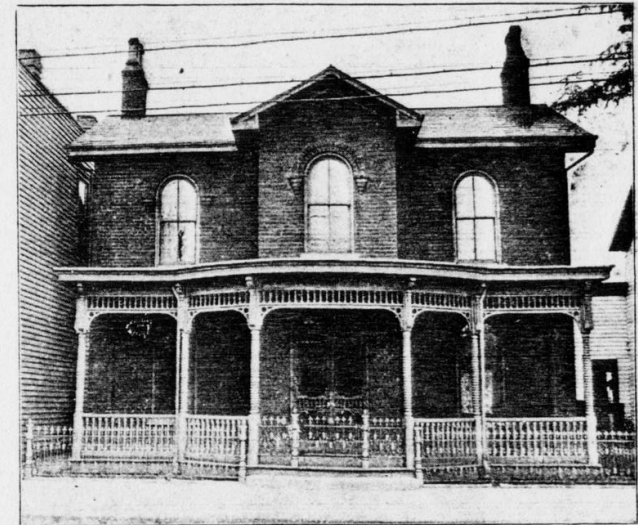

LUTHERAN PARSONAGE

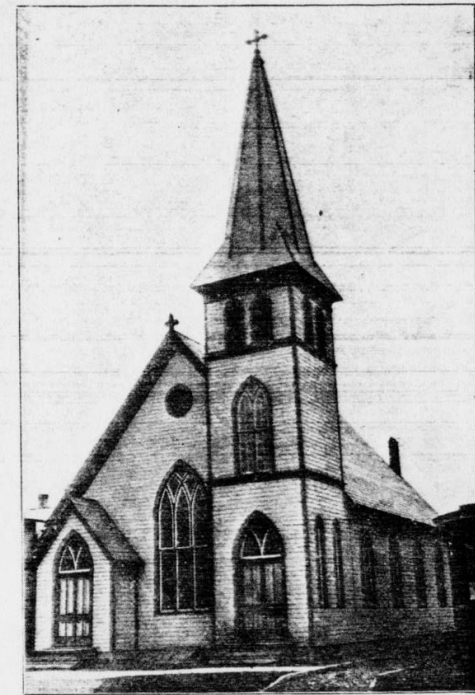

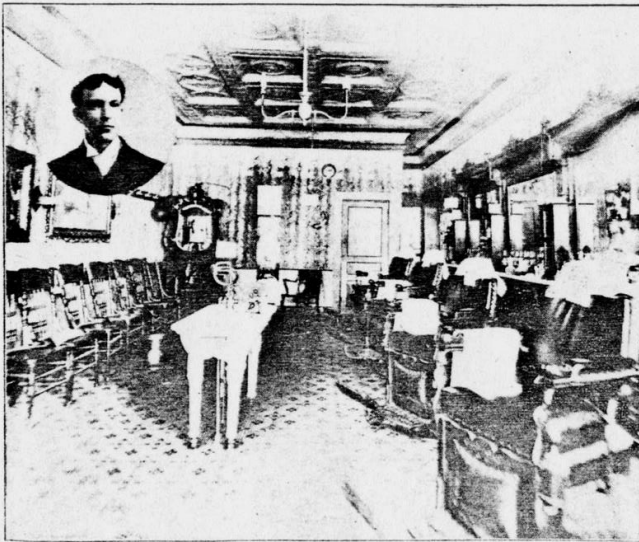

Dr. Kennedy entered the Ohio Medical College in 1874, graduating therefrom in 1876.

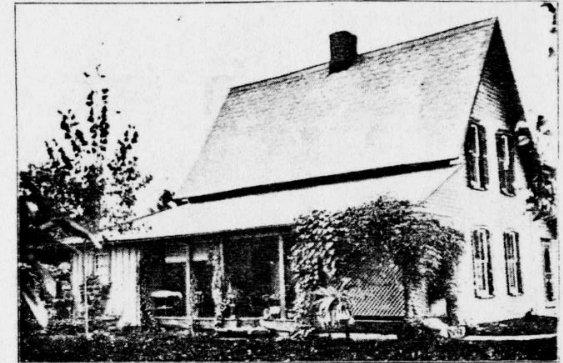

Dr. Kennedy is a prominent and useful member of the Muskingum, Perry and Morgan County Medical Societies, and is also a member of the State Medical Association.

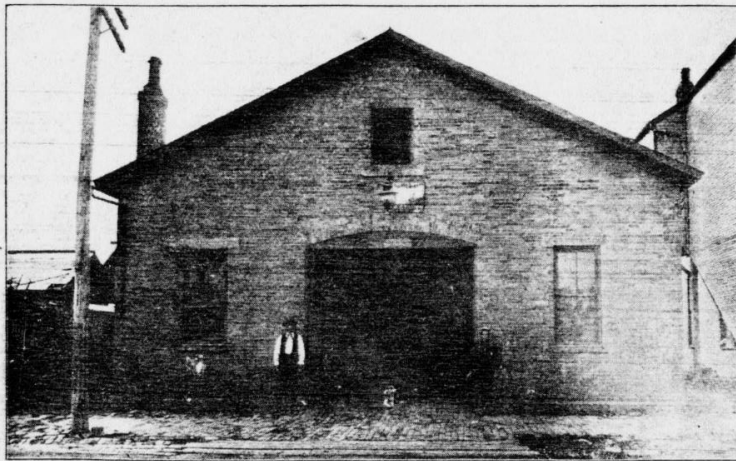

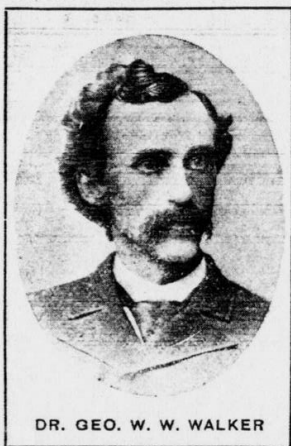

devoted much of his time during later years to these branches of commercial concern.

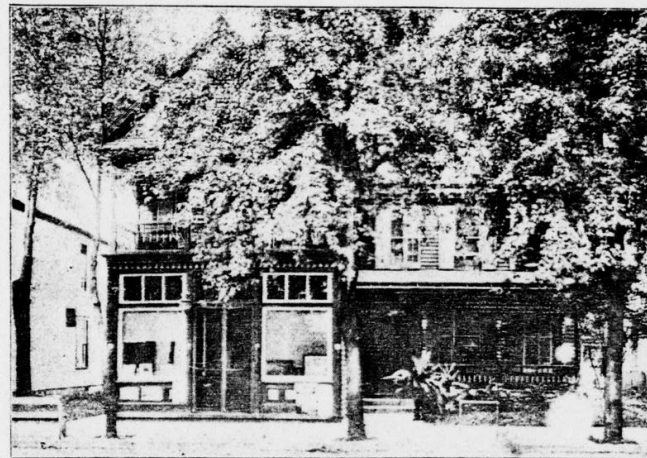
